All members and their attorney were present at today's meeting.

Dr. Houser came in to ask permission to place a "Thank You" note addressed to all who worked at the Polio clinics, and to ascertain if there was a charge for the item, would the County Commissioners pay for it. He received permission.

Clerk was asked to notify all members of the Court House Bldg Committee of the Special meeting to be held on March 20- including architect and contractor. This was done.

Dr. Locke reported that Mr. Madison Strickland had land that would be good for a Public dump site on R5. near Bean's Bar. He was asked to contact the owners and see if they are willing to sell and at what price- 2-3 acres are needed.

Sings to be placed at Dump Sites - to notify the public that these sites were located ao many yards ahead were considered. Will ask Mr. Thompson about securing these signs.

Philip Birch, St Mary's Beach called about the deer being shipped to this County. He said some like to hunt deer, some like to hunt fox, and all should have a chance to have the sport they like best. Several parties had phoned about not having deer here, and about 102 postals have been received on the matter- the Board will do as the majority desire.

Dr Houser asked for co-operation in the purchase of vaccine-polio- for the age group 20-40 years, he has \$350 on hand for this, it was suggested instead of asking people to oay, they ask all who could to make a contribution and have a small bowl or dish placed there for that purpose. This was agreed upon.

States Attorney asked permission to send Deputy to Florida for party in bigamy case-not granted-not a County matter.

Mrs. Ella Davis of Health Dept, has been acting as Registrat and receiving payment this will cease in Dec,1956 and D. Houser asked that she be granted \$300 per yr for expenses as she has gone as high in salary as law provides in Realth Depterfective Jan 1, 1957.

Prisoner in jail-Eugene Smallwood needs medication every 6 hrs- for 12 days-Dr Houser will contact Jailor to see if he will do this, and what he will charge will report back mext week.

Dr Houser asked permission to shift \$150.00 in budget to use for special training in course for treatment of certain diseases in early stages, has to go to Tenn for this- it was agreed upon.

Harry Hoke came about extra costs for Slot machines-wants to have the original regulations changed, and was advised this matter will come up before the legislature.

Check for \$625 received from St eo Isl. Improvement Association for permanent Mosquito control program- letter was addressed to Md. Univ. Dr Lengford to ask if S.G.I.I.A paid, 12½%. County paid 12½% and the State paid 75%- letter from the Md. Univ. stated this was correct.
