At this morning's meeting all members and their attorney were present.

Dr. Locke came in about a special Ordinance for the disposal of trash etc., to apply to the County. Mr. Sterling will see about this.

Mr. Wm. Herbert, Tax Assessor came in to ask permission to have new Assessment cards printed— This means a new plate to be used solely for the Tax information, and he was granted permission to have the plate made at the Boacon office and have 10,000 cards printed. Clerk was requested to write to the State Tax Commission to see if the State will pay for this, if not the County will have to, as the cards are necessary.

In re the \$450.00 check made payable to the 3 Legislators, cleak was asked to call the Enterprise and inform that since several counties paid for the housing of their delegates to the Legilature, the County considered doing the same thing but the check was returned and cancelled.

Considering the taking over of County roads, the Commissioners are anxious to know if he is satisfactory how his position can be made permanent. Mr. Sterling explained that if his appointment is worded, "permanent until his work should prove unsatisfactory etc" it will serve.

Mr. Tilp came in to ask for authority to go thead with the County Seal- this has been a subject of much discussion, and he was told to secure prices for the large seal and make a report on this later.

Clerk requested to advise Alfred Willard of Charlotte Hall that at this time the Dog Pound matter is being dropped, and if same is built at a later date it will not be in the Oaks area. This was done.

Letter was dictated by Mr. Thompson to SRC, attention of Mr. Bonnell with reference to the County assuming responsibility for construction, reconstruction and maintenance, effective July 1, 1957. Copy was sent to MCT and Mr. ELDuncan

Letter to the SRC rferring to the Traffic Signal light at ShangriLa Dr and GM Road, advising that the County will assume half the cost of installation.

Miss Dent came in about a State School Loan amounting to \$844,000. Again the Commissioners asked for a breakdown of this amount and she advised that in her letter of Dec 13.56 she made one. The copy of that letter in this office does not have the requested breakdown. She will send a copy showing the breakdown. The Fed. Govt is making a grant of \$165,000. for Jarboesville, but \$247,290. is needed and she asked permission to use \$65,000. of the Incentive Fund to start this project. She also said a school in the Town Creek area is necessary but expects to receive a grant for that. Asks Bd to imtimate they will borrow \$85,000 and they will only have to pay on that amount-but needs much more for other schools Integration will begin in the Public schools in Sept 1957, wherever administratively possible.

It was decided that when the room is ready for use the Unemployment Compensation meetings will be held in the Trial Court room.

Appointment was made for a meeting with the Bd of Education in this office for Tuesday April 116,1957 at 3 pm to discuss school situation in detail.
