The Commissioners and their attorney met in regular session today.

SRC- Messrs E.C.Duncan, Res. Engr., with Asst. R.E. Kenneth Webb, ab Res. Engr Douglas Bond and M.C.Thompson, Jr., appeared relative to the cut in payroll. Since there had been one resignation and one retirement, with an anticipated third retirement, the Board felt it would not have to cut the payroll, but not make any appointments to these vacancies. Several of the employees were advised to pay all debts or they might be discharged by the SRC.

Roads for 1957-8 Mr. Duncan requested that a road program for 57-58 be prepared next week. Money from the Road Bonds will be available in August. There is \$26,000 balance in the 1956-7 budget and Mr. Duncan will obtain a letter advising if the County makes this advance to the SRC, they will be reimbursed later. When letter comes check will be forwarded.

Camp SAYSF road under consideration. Mr. Thompson will contact Mr. Maynard Barnes to see about R of W-requested road is 3/4 mi and serves 3 houses.

Letter was written to the SRC asking that Plans and Specifications for a bulkhead at Patuxent Beach Road, 7 Gables Hotel area be prepared by the SRC at a cost of not over \$200.00. Bids will be obtained when this infohas been received by the Commissioners.

TB Association will give \$500 towards the salary of an all time technician for XRay work, Jane Gough to be assigned to this work and balance paid from budget for Health Dept clerk. 57-8 Budget for Health Dept is \$21,945 and corrected budget recd from State Health Dept is \$21,327-\$618.00 balance Dr. Houser would like to purchase a camera for use in their work. Will ascertain price etc and present same at next meeting.

Gen. McInenry, Park Hall reports many wild dogs running at large in that area-he is anxious for fear rabies might break out here. Mr. Wm.Loker is to advise Mr. Alvey concerning law on this.

Wilmer Bowles, Town Commissioners brought in a breakdown for construction of sidewalk, retaining wall, necessary grading and curbing on west side of Court House, 4' sidewlk 6" gutters, would cost between 5 and 6,000\$. Mr Bowles had asked the So.Md. Elec. Co-Op Inc to remove box and pole which is in area of anticipated sidewalk. He feels that if box is turn d to other side of pole, and rearrange wires, there would just be a 4" pole in the sidewalk which would not have to be removed. Commissioners agreed to all of this and sent letter to Town Commissioners advising they would pay at the costm bot to exceed \$6,000 for the sidewalk and curbs etc., and asked to review the plans and specs before bids were advertised.

Letter to Secretary of Planning and Zoning Commission asking for a detailed list of all Zoning Ordinances which it was alleged H<sub>i</sub>ram Millison, Betty Millison, his wife, the Park Shopping Center Inc and Patuxent Development Co. Inc were practicing.

In the matter of the Barber Memorial Club, and roads leading thereto, a second letter was sent to Mr. R.J.Jorolemon, sec of the Club advising that the matter was under consideration but nothing definite determined.
