NO PARKING signs to be erected as requested in Lex.Pk. Chamber of Commerce letter signs should be on both sides of the street at this point

Little Snow Hill Road accepted - SCR was so advised by letter and asked that road be placed on County Road system for maintenance CBG 70- Folio 446

SRC needs plats on Pegg Road- clerk requested ask WIBowman for same

California-Post Office road dangerous, to be placed on second list for 1957-58

Barefoot Road- deed accepted- to be built later. Stevens Road-

Charlotte Hall road- Whalen, Mr. Alvey and Mr Guy will look over road and see what can be done, may put in gravel this winter. Whalen spent nearly \$100 for survey etc., misunderstood decision that road could not be built. Decision of Commissioners to be made later.

Clerk requested write check for \$300.00 each for 2 busses just bought by Bean Brothers. \$600.00 Mr. Gero of the State Tax Commission came in with State Sen. Jos A Mattingly and delegates J. Frank Raley and Frank A. Combs to consult with the group about Trailer Tax laws- a lengthy discussion followed but nothing can be done since the next session will be a short one-for emergency matters only. This matter will be discussed later, with a hope to enacting a law to bring in revenue from the trailers and parks, all of them.
