Mr. Hodges will meet with Leo Bean and the above group Sunday morning and they will make better arrangements Mr. Hodges will report at next meeting.

Dr. John R. Foster- Mosquito Control, Univ. of Md. came in to talk about the budget for 1959-60 and was told it contained \$1,500 and the Univ of Md. was to allocate it to the various projects now under that project. He presented 2 bills for work on St. Geo. Island and a summary of the Temporary work Program. He suggested the Commissioners hire the equipment used in the project and keep it in the County to lend us to the civic groups- The Commissioners felt it would be wiser to continue as at present. Clerk was directed to secure a small ledger for Mosquito Control accounts.
