All officials present.

Clarence Ardinger, representing the Civic Ass'n of $\frac{1}{2}$ Pone Pt spoke of the road around that area, now being gravelled. He asked for the future plans for the road and was advised that the Commissioners plan to surface treat all roads being gravelled now, and this road is included in the program.

Fayette Latham, and Maj. Brazelton of the Aviation Yacht and Country Club explained they had devised new plans to prevent the sewage from draining into the Wicomico River; adding that the State Health Dept required the Commissioners to establish a Sanitary Commission before that Dept would grant them a permit and this Commission must be set up for at least 6 months after the plans are put into operation in the event there is a breakdown of the new project. Commissioners will advise the organization of their decision on Jan 2,1962 after they discuss the matter.

Messrs. J. Claude Johnson and Webster Bell of the Planning & Zoning Commission discussed the appointment of an attorney who would act for the Commissioners and also the P & Z Commission. No decision was reached.

Sen. Walter B. Dorsey requested that he be appointed to the Planning & Zoning Comm., as well as to the County Commissioners for attorney. No decision.

Jr. Raley was present when a group from Golden Beach Sub-Division came in-Mr H.W.Kinney, Mrs. Harold H. Hodges and Mr and Mrs McDow, following up their meeting of November 7th. The property owners in that area are satisfied with all progress except speed signs have not been erected, and the bad curver is still in the road. They were advised nothing can be done about the curve until the R/W is secured, and the SRC will specify where the R/W is needed on the curve. Jr. Raley will stake out the curve and give the sheet to the Golden Beach Citizens Ass'n, which they are to sign. The road will be maintained this winter and pot holes repaired now. R/W should be secured and road staked out within 2 or 3 weeks.

Chas. Davis owns property near Porto Bello and is interested in the old abandoned Flat Iron Road; t is gives access to his property, about ½ mi from the Porto Bello Rd. Comms. Hodges will meet Mr. Davis and discuss this matter
