Tuesday, January 30, 1973

READING OF MINUTES

The final draft of the minutes of December 19 were approved as corrected. Commissioner Guy made a motion that the minutes be entered into the Minute Book. Commissioner Aud seconded the motion and Commissioner Bowles made it unanimous.

OILING SCHEDULE ON COUNTY ROADS FOR FISCAL YEAR 1973

Douglas Bond stated that last year's oiling schedule was \$102,198. \$128,486.25 was actually spent. There was \$26,288.25 additional spent. He presented a list of the roads to be treated next fiscal year. Mr. Bond is requesting \$100,000 for next year's oiling schedule and an additional \$26,288.25 for the deficit of last year. It was recommended that the 1973 oiling schedule be funded in the amount of \$130,000 in order to avoid further deficit spending. Mr. Harris Sterling is to check the budget for this.

MAYPOLE ROAD

Commissioner Bowles asked Mr. Bond about work to be done on Maypole Road, specifically the ditches and shoulders that had been washed away. Said road should be surface treated in order to protect the County's investment and to prevent further erosion of the shoulder and ditches.


PRESS CONFERENCE
