#### 6. ST MARY'S COUNTY BOARD OF HEALTH

#### A. BOARD OF HEALTH

**Present:** Dr. Meenakshi Brewster, Health Officer

Dr. Brewster presented the COVID-19 data dashboard on the Health Department's Website. There have been 1,435 COVID-19 cases in St. Mary's County with 59 deaths. Twenty-three percent of county residents have been tested and the positivity rate has decreased. Major sources of community spread of the COVID-19 virus continue to be gatherings, large parties and events. She also discussed the COVID-19 Wastewater Surveillance data; the St. Mary's County Health Department Community Outreach program; Mask in St. Mary's initiative; partnering with Equity Task Force for school based Health Centers at Margaret Brent Middle School and Spring Ridge Middle School; and the importance of receiving the influenza vaccine and travel recommendations.
