Dr. Brewster discussed the COVID-19 data on the Health Department's Website. There have been 2,350 COVID-19 cases in St. Mary's County with 62 COVID-19 related deaths. Thirty percent of county residents have been tested and the positivity rate has increased. There are Covid outbreaks at all three long term care facilities. At this time, major sources of community spread of the COVID-19 virus are family gatherings, dinner parties, workplaces, sporting/recreational activities, and events.
