5. ST. MARY'S COUNTY BOARD OF HEALTH

A. BOARD OF HEALTH

Dr. Stephen Michael, Chief Medical Officer, Medstar St. Mary's Hospital

Dr. Brewster discussed the COVID-19 data on the Health Department's Website. There have been 3,797 COVID-19 cases in St. Mary's County with 83 COVID-19 related deaths. Thirty-six percent of county residents have been tested. There are COVID-19 outbreaks at two long term care facilities. COVID 19 Vaccination data has been added to the data dashboard on the Health Department's Website. She explained the vaccine supply, phases to administer the vaccine to citizens and that the National Pharmacy Partnership (CVS/Walgreens) will assist with vaccinations. Dr. Michaels discussed the Medstar St. Mary's Hospitals' preparation and operation during the COVID 19 pandemic and advises that to date 700 Healthcare workers have been vaccinated.
