David Weiskopf, County Administrator opened the public hearing for the FY2024 Recommended Budget at 6:30 pm in the Chopticon High School Auditorium. Following introductions of honored guests, Mr. Weiskopf introduced Commissioner President Guy who introduced the other Commissioners and provided welcoming remarks.

Ms. Cudmore noted there would be four public hearings tonight: Constant Yield Tax Rate; St. Mary's Fees and Charges; Hollywood VFD Tax rate to .056; and FY2024 Recommended Budget She presented an overview of the \$ 314 million FY2024 Recommended Budget highlighting Revenue Sources and General Fund Expenditures. The budget includes a Constant Yield Rate at \$.08478 per \$100 of assessed value. Funding for the Board of Education is \$127 million and the Sheriff's Office \$62 million. Funding for County Departments is \$68.5 million. County funding includes 24 planned vehicle replacements. County fees and charges for Aging & Human Services, Senior Center Room Rental Rates; Emergency Services, Rescue Billing Transport Fees; Land Use and Growth Management, Development Service Fees; Recreation and Parks, Wicomico Golf Course Fees; Recreation and Parks, Recreation Activity Fees; Soil Conservation, Erosion and Sediment Control Fees. Hollywood VFD – 6th District Fire Tax to 5.6 cents. 26.25 positions were added to county departments, which included 18 Emergency Medical Technicians in the Emergency Services Medical Billing Fund. A Merit Increase on the anniversary date for Regular and Regular Part-Time employees, and a 4.5% COLA.
