- 2. Requesting amendment of Title 28 of the Alcoholic Beverages and Cannabis Article to create an annual beer and wine license for nonprofit community theaters. Request Made By: Robin Finnacom, on behalf of The Newtowne Players, Inc.
- 3. Requesting Amendment of § 28-1308 of the Alcoholic Beverages and Cannabis Article to add a class of beer, wine and liquor tasting permits. Request Made By: David Dent, on behalf of the St. Mary's County Licensed Beverage Association
- 4. To request funding be allocated to a program subsidizing Southern Maryland animal agriculture and livestock farmers who transition to plant-based agriculture. Request Made By: Alissa Kircher, citizen.
- 5. To request funding be allocated to a program to better preserve local produce for long-term storage options. Request Made By: Alissa Kircher, citizen.
