Commissioner President Guy called the Joint Meeting of the Commissioners of St. Mary's County and the St. Mary's County Delegation to order at 6:00 p.m. in the Chesapeake Building Meeting Room, Governmental Center.

Following opening remarks by Commissioner President Guy and Delegate Todd Morgan, John Houser, Assistant County Attorney presented the proposed legislative items.

Proposal #1 - Requiring State-Owned Nursing Homes to Report Certain Deficiencies to Local Government Body

Proposal #2 - Creating New Class of Beer and Wine License for Nonprofit Community Theatres

Proposal #3 - Creating New Class of Permits for Beer, Wine, and Liquor Tastings

Proposal #4 - Reporting to the General Assembly on which Public Highways the Commissioners Consider Appropriate for the Operations of Golf Carts

Other #5

Delegate Matt Morgan presented 3 items pertaining to transparency that he is recommending for draft legislation: (1) Require St. Mary's County Housing Authority to issue a report to the County Commissioners and the Delegation and make available on their website reporting how many housing vouchers have been issued, the high and the low, the average amount of those vouchers, the location of recipient, and the funding source of the voucher; (2) Require the Local Department of education to post a performance dashboard to their website containing test scores, graduation rate, student population, average class size, student suspension, crimes committed on school property, student arrests, and incident report, as well as other information that may be helpful to parents; and, (3) A local law allowing Home School Children to participate in Public School extracurricular activities at their locating zones school.

Senator Bailey discussed bills that will affect the County and/or State that have been pre filed or are on their radar. The Jamari Duckett Law, which increases the penalty for a person who kills another person and is convicted of manslaughter with an automobile or vessel. A Waterway Notification System, like the Amber Alert and Silver Alert, is an initiative of Anne Arundel, St.

Mary's, and Dorchester Counties. He mentioned an incident where watermen were near an area where a drowning occurred and had they been alerted after the 911 call was made, they could have responded immediately. He noted a placeholder for a Sports Complex in St. Mary's County. Also under consideration is a Local Bond Initiative which would help areas like Valley Lee with solar panels, Solomons with their rescue boat, Ryken's refurbishment and Kennedy Krieger School in conjunction with Greenwell Park.

The County Administrator then provided guidelines for citizen remarks and opened the public comment period.
