The Director of the St. Mary's County Department of Land Use and Growth Management conducted the public hearing for and on behalf of the Commissioners of St. Mary's County as authorized in Resolution No. 2015-14. The hearing was opened at 1:00 PM by Director Hunt.

The proposed amendment would amend the water and sewer categories from W-6D and S-6D (service in 6 to 10 years, developer financed) to W-3D and S-3D (service in 3 to 5 years, developer financed) for 20.53 acres described as Tax Map 34, Grid 23, Parcel 0091 in the 8th Election District, Tax ID 015562. The Property is located at 22835 Old Rolling Road in California. This amendment is requested to facilitate community water and sewerage service for proposed multi-family development.

Notice of this public hearing was published in the Southern Maryland News, October 7, 2022, and October 14, 2022. Certifications of publication, property posting, and mailings are in the case file as *Certification of Mailing and Posting*.

Advance notice of the public hearing process was also provided to MDE, MDP and other neighboring jurisdictions.

As a prerequisite to this public hearing, the Planning Commission conducted a public hearing on May 23, 2022, and recommended adoption of the amendment.

The proposed amendment is described in the September 30, 2022, Public Hearing Staff Report which is in the case file as *Staff Report*.
