#### Meeting: Teleconference—Called to order by Don Haskin

- 1) All electrical work done in St. Mary's County that does not require a building permit will require an electrical permit. The permit will be obtained through Planning and Zoning at a cost of \$20.00. Once the permit is obtained than the electrician can file for an inspection at the inspection agency he uses.
- 2) Electricians, Inspectors and Homeowners wanted to speak at the monthly board meeting will need to submit the subject to be discussed by email one week before the board meeting. This will allow the board to be prepared and have all parties involved attend the meeting.
- 3) The board approved July meeting minutes.
- 4) Homeowner Exams will only be given in January and July
- 5) We will start accepting 2021 license renewals January 1st 2021
- 6) The new 2020 NEC will take effect in St. Mary's County on April 1<sup>st</sup>, 2020. All building permits that include electric & electrical permits issued before April 1<sup>st</sup>, 2020 will still fall under the 2017 NEC.
- 7) Maryland passed House Bill 586. This requires all knife blade disconnects mounted outside on solar systems to have a seal that prevents the disconnect from being opened without removing the seal. This went into effect on July 1<sup>st</sup>, 2019
- 8) Two master exams were given. 2 fail, 0 pass. One applicant who scored above a 60% was able to review their test and will be administered another test on September 24<sup>th</sup>, 2020
- 9) Annual report was completed and submitted.
