John Deatrick advised we are now realizing once we extracted information from 311, and other complaints that we have multiple whole neighborhoods with nuisance flooding in both coastal or interior locations. We're characterizing those issues as

- 1. County owned facilities that need repair or upgrading (example a forebay owned by DPW&T that flows to an unkept HOA pond, so really two problems documented in triennial MES inspections for MS-4 program)
- 2. Historic problems neighborhoods only a few feet above sea level (Example Golden Beach)
- 3. Problems caused by Developer designs for site, stormwater systems and/or construction (Example Cecile Mills and Broadcreek)
- 4. Problems caused by defunct HOAs (Example Lavender Estates and many, many others)
- 5. Aging infrastructure (Example Mechanicsville Rd. rusted out culverts near Coffee Hill Run near MD5 and Yowaiski Mills Road)
- 6. Private matters that affect County ROW (Example Andover Estates roadway ditch and yard flooding generated by runoff from farm fields)
