A. LOSAP Points and Service Credits - Benefits Recommendations

Catherine Pratson presented a summary of the request from the volunteers for an increased benefit as well as a request for the board to consider hiring Bolton to update their fiscal analysis of the cost of that benefit. The goal would be to have Bolton bring their analysis back before the board at the next meeting on April 28, 2023. The analysis could then go before the Commissioners at their May budget work session meetings, should they want to take any actions for the FY24 budget. It was requested that Bolton also add two different calculations for the discount rate, one at 6% and the other at 6.5%. Additionally, it was pointed out that since Bolton's cost analysis was based on the 2019 valuation, they can use the 2022 valuation for their analysis.
