#### A. LOSAP Increased Benefits - Bolton's Revised Cost Analyses

Tom Vicente of Bolton Partners then presented a revised analysis presenting various scenarios using 2 different assumed rates of return – all figures were based on the July 1, 2021 valuation and assumptions.
