- 1. Any road improvement (s) required by the state and county must be concurrent with the issuance of the Certificate of Occupancy
- 2. Obtain a variance from the Board of Appeals to reduce the required 30' type "C" Buffer Yard along the southwestern boundary
- 3. Add an additional ADA parking space to the site.
- 4. \$18,500 will be allocated towards mitigation for traffic improvements as discussed at the intersection of MD 235 and FDR Boulevard.
- 5. Off-loading or on-loading of cars in bulk shall occur on-site, and not on MD 235.
- 6. User shall not allow any test drives on any of the following roads: Oak Drive, Woodland Acres Road, Potter Drive, Old Line Court or any other road or right of way in Woodland Acres or Woodland Heights.
