#### 4. Old Business

#### a. Program Updates

- i. The pool bubble was reinstalled over the Great Mills Swimming Pool on Wednesday, September 23. Pool reopened on Saturday, September 26. All the same precautions will be followed with limited attendance during aqua aerobics, lap swimming and open swim. Schedule is available online and reservations must be made in advance.
- **ii.** Limited fall programs opened for registration. Small class sizes will be available for recreational gymnastics, outdoor sports such as cross country and dance classes. Family Skate will return in mid-October on Sunday afternoons after a successful re-opening in July & August.
