1. CALL TO ORDER

Richard Johnson, Chair, called the Redistricting Board Public Hearing to order at 6:00 pm in the Chesapeake Building, 41770 Baldridge St., Leonardtown, MD.

3. PUBLIC HEARING

A. REDISTRICTING BOARD PUBLIC HEARING

Present: Richard Johnson, Chair, Redistricting Board Matthew Burgan, Vice Chair, Redistricting Board

Prior to discussing the proposed redistricting map, Mr. Johnson explained that all meetings in the County are run by Roberts Rule of Order. He explained that all Boards and Commissions are run the same and distributed Bylaws of the 457(b) Governance Committee of St. Mary's County to all Board Members. Mr. Johnson then explained that the Board looked at the current district map and applied the current census data to it to see if it met the 10% required by law and it did not. There was a population in-balance of 7,641 in District 4. Each member of the board then generated maps using population data and the proposed redistricting map being presented was approved to bring to public hearings.

Mr. Burgan welcomed citizens to the public hearing and thanked them for coming out to provide input. He explained that the ultimate step in drawing the final redistricting map is public input. He explained that citizens can view all past meetings of the Redistricting Board Meetings and Public Hearings on the County's YouTube site and all documentation being used can be found by logging in to stmarysmd.com and clicking on BoardDocs.

John Houser, Assistant County Attorney, provided guidelines for the public hearing and opened the hearing for public comment.
