#### A. Asset Strategy Portfolio Update - Quarter Ending September 30, 2020

David Saunders and Ed Boyer presented the portfolio update. Discussed the general market changes for the quarter ending September 30, 2020 referencing page six of the St. Mary's County Retirement Trust: Quarterly Investment Analysis. Looking at the portfolio allocation on page 9, in the table you can see that we are in compliance with our

policy range. We are slightly overweight to policy in the Large Cap, Small Cap and Mid cap Equity, and under allocation is most prevalent in the Real Estate section which we have been adding managers there, so over time that will close the gap.

Ed Boyer went through the Total Fund Investment Analysis beginning on page eleven pointing out the results for each portfolio compared to target and his assessment of the Managers performance. Ed turned to the December 2, 2020 Market Value update and reviewed the change in the portfolio to that date.

Ed Boyer turned to the JMI Equity Fund X November 2020 overview and recommended a capital commitment of \$1-1.5M to the JMI Equity Fund X.
