#### A. Actuarial Valuation as of July 1, 2022

Tom Vicente and Kari Szabo of Bolton Partners presented the 2022 Actuarial Valuation report, as well as the accounting results as required by GASB 74 and 75.

The board asked that Bolton come back with a revised report at the next meeting in April, showing a funding schedule of 100% versus the current policy rate of 80%. Also, using a 6.5% discount rate vs. current 6%.

#### **B. Q4 Investment Performance Report**

Pat Wing of Marquette Associates began with an overview of the Market Environment in Q4 followed by a detailed review of the Portfolio performance in Q4. The Market Value of the fund for Q4 was \$110.1M. The portfolio net investment change was \$5.6M and the portfolio returned 5.3% (net) vs. policy index of 5.8%.
