# **Director Report**

Assistant Director Jennifer Neff is presenting on behalf of Director Alexis Zoss

The agency has put a focus on recruitment of resource parents for both children and adults as both kinship or adoptive families. There are currently 20 resource homes and 74 children in care. There are 5 Project Home providers and 6 adults in care. The agency has been building on trauma informed resource training which will be provided quarterly the first of which was completed this month. During the first training, parents had breakout sessions with a provider giving them the opportunity to discuss challenges they may be facing as well as individual support. A total of 9 families including 14 children were in attendance.

SMC DSS staff attended and had a display table during an event at Ann Marie Gardens teaming up with Calvert County DSS employees to provide information to the public on becoming foster care and adult providers.

SMC DSS has sent out flyer information for 4 months on the Val Pack coupons. From this we have had 2 interests for children and 4 for adults.

DSS has had a recent case involving a home which is unhabitable for the family. The household consists of a father and 4 children. The mother is deceased. To avoid placing the children in foster care, the agency has been hoteling the family. The home requires extensive repair. The children suffer from high anxiety. There is an adult child also in the home with 2 children of her own and is expecting a third child. The children do not want to leave their father. The agency has reached out to three contractors regarding repair of the home. The first estimate was \$100k. The home needs the sub-flooring replaced to make it safe to live in which is very costly. This may be an opportunity for the board to assist with donated funds. Christmas in April can be explored as an option as well.

The board currently has approximately \$1000. Michael will reach out to MASSB to find out how to retrieve the funds.

Q – Is there a possibility of replacing the home vs extensive repairs?

This is a possibility depending on the rising cost in the housing market.

Habitat for Humanity may be a resource.

Christmas Caring – Make sure the family receives a form to submit for gifts

Q – What is the length of stay for hoteling?

There is currently a plan in place for a possible ERAP extension

Medical Respite – Update The group met today, there may be an opportunity for a grant which is due December 7, 2021. Request for nursing oversight would be expanded. Both Dr. Michaels and Dr. Brewster are on board with the plan. "Soft Opening" possibility The building is approximately 70% complete
